

# The Ulla Bondeson Fund Research seminar – Socialhögskolan, Lunds Universitet November 10-11, 2022

# **Invitation**

Ulla Bondeson was an active and very productive Scandinavian criminologist for more than 40 years. She was a professor in sociology at the University of Lund and later she became professor in criminology at the University of Copenhagen. During her long active career, Ulla Bondeson became an important and respected person in the international criminological society. She held numerous important positions and received many honours such as the Sellin-Glueck Award of the ASC in 1995, and she became a Knight of the Dannebrog (the Danish flag), which was conferred by the Queen of Denmark in 2006.

David P. Farrington and Lawrence W. Sherman wrote about Ulla Bondeson in their obituary: *Ulla Bondeson was a remarkable and very distinguished pioneering criminologist. Ulla was extremely concerned about the damaging effects of imprisonment.* And further: *She was a highly intelligent, multilingual and very cultured person who also had a hearty laugh and a great sense of fun.* 

After her death in 2009, Ulla Bondeson's personal archive and library were donated to the University of Lund and her personal assets were established as a fund for Nordic criminological research.

Each year the board of the Ulla Bondeson Fund arranges a research-seminar in order to stimulate and support Nordic research in legal sociology and criminology.

## Can the damaging effects of imprisonment be prevented?

- Attempts to prevent new crime during prison time and after
- Challenges and ambitions in the probation sector (kriminalforsorg i frihed)
- The time after imprisonment
